- 1) Date Of Application 11-00 A M up to 3.00 P.M. upto 07.12.2015 & 08.12.2015 along with valid VAT,I.Tax,PAN Card,P.Tax,Tread licence and credential (in form of Payment Certificate and completion certificate of a single work)of the undersigned must be submitted in original and photography thereof and Tender Paper will be issued by the Pradhan,Baidyanathpur Gram Panchayet during office hour11-00 A.M up to 3.00 P.M. on 10.12.2015
- 2) The original documents will be returned after scrutiny and the photocopy will be preserved by the the Pradhan. Payment certificate must be of last 3 financial years.
- 3) ESMF guidelines will strictly followed at the time of work i.e A) No Child labour should be engaged in the work. B) No vulnerable and backward class/casted should be exploited. C) The work should not do any harm to Environment.
- 4) Royalty, Saies Tax @3% (5% if VAT No. is unavailable) from the all bills and Income Tax @ 1%. Earnest money @ 2.0 % of the total project cost should be deposited along with Tender Paper only in the form of cash only.

- 5) In case of successful tenderer 10% (ten percent) security money will be deducted from each successive bill and in that case earnest money (2.0%) already deposited will be taken into account. Earnest money of first successful tenderer and second successful tenderer will be retained upto the period which the Gram Panchayat decides. The tender form will be duly filled in and signed by the applicant by his own hand writing.
- 6) Contractors have to execute the work on strict supervision of technical officer of the Panchayat.
- 7) Acceptance lowest tender is not obligatory and the undersigned reserves the right to accept or reject any or all the tender without assigning any reason. What so ever and also to split up the tendered work to more than one contractor in the interest of scheme execution.
- 8) The specification should be maintained. Below specific materials will be rejected forthwith after supplying any material, approval of Nirman Sanayak regarding quality and quantity of the same will be obtained.
- 9) No arbitration for the work will be admissible as per Govt. order no 3370(a) dated 20/03/1987 (Rules 19 of P. W. D road 1987)
- 10) Time is of the essence of the contract. The successful contractor must complete the work within the time specified for completion. No extension of time will be allowed except in special cases. If a contractor fails to complete the work within the stipulated time the work order issued in his favors will be cancelled without assigning any reason therefore. The undersigned may also proceed to get the remaining work finished by any other means including through other contractor.
