- 4 In case of bid/tender emanating from cartelization of bidders, entire tender process will be
- 5 Bidders must quote rates in absolute numerical values (both in figures and words) against the estimated cost. Rate quoted in percentage term will be rejected.

Rate offered by a bidder in a particular Tender shall be treated as final and subsequent negotiation with that bidder for change in price shall not be allowed.  
Multiple bids (more than one bid by same bidder) and variable rates (different rates of same item by same bidder) shall be rejected outright.

Bidder must submit sealed envelope clearly mentioning serial number and name of work on top of the envelope.
